This guide provides potential underwriting outcomes for a variety of conditions. In addition to an applicant's condition, we consider all details such as occupation, treatments received and comorbidities, if any. This is only a guide and final underwriting decisions will be based on assessments of all risk factors.

Common Terms

The terms "rating" and "postpone" are used throughout this guide. "Rating" refers to a substandard premium rating. In these cases, the premium charged will be increased by the percentage indicated. A potential outcome of "postpone" means an applicant may be eligible in the future. This is usually when a period of time has passed or an event has occurred.

Common Restrictions

Restrictions may be placed on policies with substandard premium ratings or other modifications, such as:

- Policies offered with a substandard premium rating of more than 50% are eligible for a maximum benefit period of five years.
- Policies offered with a substandard premium rating of more than 75% are eligible for a maximum benefit period of two years.
- The Benefit Increase Rider and waiting periods less than 90 days are not available for policies with a substandard premium rating of any amount or if the benefit period is restricted to a maximum of five years, as indicated in this guide.
